



NEGOTIATED PARKING AGREEMENT

In an effort to promote fair and equitable working conditions, and to improve moral, this local agreement is entered into by the Miami Passport Agency/Union Management Committee (MM/UMC) regarding the distribution of free parking spaces for Bargaining Unit Employees (BUEs) in 2017, in accordance with Article 12, Section 16f (vii) of the Master Agreement.

1. Based on a survey sent to all BUEs in November 2016, 27 BUEs requested free parking for 2017.
2. Of those 27 BUEs, 27 BUEs will receive free parking for the period of January 1, 2017 – December 31, 2017.
3. The list of the 27 BUEs who requested/will receive free parking in 2017 is attached.
4. Remaining parking spaces for 2017 will be distributed at Management's discretion.
5. If the Agency hires new BUEs or receives any transfer BUEs during the 2017 calendar year, those BUEs may request and receive a parking space if one of the 27 designated spaces for BUEs in 2017 is available.
6. Current BUEs who did not request a parking space prior to the assigning of parking spaces, may still request a parking space at any point during the calendar year and receive a parking space if one of the 27 designated spaces for BUEs in 2017 is available.
7. The Miami Parking Agreement shall remain in effect through the end of the 2017 calendar year. The Agreement shall be renewed annually on each anniversary date of this signed agreement unless either party gives written notice to the other of its desire to amend or modify the Agreement. However, if the current lease for the Miami Passport Agency changes or changes are contemplated before the end of the calendar year and the new lease no longer includes the same parking allotment, the Agency will provide the Union with proper notification under Article 12, Section 9, of the Master Agreement, and both parties may exercise its rights at that time under Article 12 to negotiate an amendment to this agreement or negotiating a replacement agreement which will address the changes in parking allotment under the new lease.
